insurance claims are due to the disease. And one in nine Americans age 65 and older are afflicted, according to the Alzheimer's Association. And the rate jumps to one in three for those 85 and older. That's huge."

This puts a big burden on American households. "Families must be prepared to care for those who, for mental reasons, can no longer care for themselves," Wilson points out. "It's a serious national issue."

"We're proud to contribute to the Alzheimer's Association," says Wilson. "We're also glad we can make a difference directly, through our company's services."

When the disease advances, a loved one may forget where they are or when to eat, or have trouble going to the bathroom, Wilson points out. "Family members must care for them personally unless a long-term care financial solution is in place -- some way of paying for professional caregiving."

A sound plan can ease the burden, which can include lifestyle stresses and diminished earning capacity.

The solutions recommended by Wilson's organization include traditional long-term care insurance, life insurance or annuities with long-term care riders, critical illness insurance, and other options ranging from health savings accounts to Medicare supplement plans.
